Recording of Trade Union Facility Time - The Trade Union (Facility Time Publication Requirements) Regulations 2017

1st April 2017 - 31st March 2018

The request for information was sent to a total of 29 Staffside Representative with a response received from 17. For the purpose of the report and in the absence of the relevant information the 12 non respondents have been recorded as spending 0% of their working time on Facility Time (Table 2). The HR department has subsequently set up a system to request the relevant information on a quarterly basis.

From the information received Trade Union Facility Time has been categorised into the following (this is not an exhaustive list)

<u>Trade Union (Activity)</u> – Examples provided: Branch Meetings – AGM's – Women' National Conference – Union Health – Delegates Conference – RCN Board – Regional Disability Meeting – TUC Women's Leadership – National Conference – Regional Committee – RCN Congress – Full time Officer Supervision
